*(Lemery Water Supply System Expansion Program)*

1. The **Lemery (Iloilo) Water District**, through R.A. No. 10717 (FY 2016 GAA) to finance the construction of water supply to non-creditworthy water districts from the Government of the Republic of the Philippines intends to apply the sum of *Nine Million Forty-Nine Thousand Four Hundred Sixteen Pesos (₱ 9,049,416.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for the **PROCUREMENT OF INFRASTRUCTURE PROJECT FOR THE CONSTRUCTION OF WATER SUPPLY SYSTEM FOR LEMERY WATER DISTRICT**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Lemery (Iloilo) Water District**, through the **Bids and Awards Committee of Dumangas Barotac Nuevo Water District**, now invites bids for **PROCUREMENT OF INFRASTRUCTURE PROJECT FOR THE CONSTRUCTION OF WATER SUPPLY SYSTEM FOR LEMERY WATER DISTRICT**. Completion of the Works is required *Three Hundred (300) calendar days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from the **Dumangas Barotac Nuevo Water District, BAC Secretariat at BAC Office, PD Monfort North, Dumangas, Iloilo** and inspect the Bidding Documents at the address given below from **9:00 am to 4:00 pm (Mondays to Fridays except holidays)**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **October 18, 2020** from the address below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Ten Thousand Pesos Only (**₱10,000.00**).
6. The **Lemery (Iloilo) Water District**, through the **Bids and Awards Committee of Dumangas Barotac Nuevo Water District** will hold a Pre-Bid Conference on **October 28, 2020, 9:30 A.M. at BAC Office, DBNWD Office, PD Monfort North, Dumangas, Iloilo** which shall be open to prospective bidders.


7. Bids must be duly received by the BAC Secretariat at the address below on or before 9:30 A.M. on **November 9, 2020**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.



Bid opening shall be on **November 9, 2020, 1:30 P.M., at BAC Office, DBNWD Office, PD Monfort North, Dumangas, Iloilo**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The **Lemery Water District (LWD)**, through the **Bids and Awards Committee of Dumangas Barotac Nuevo Water District**, reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.

**ELIGIBILITY REQUIREMENTS FOR THE PROCUREMENT OF  
INFRASTRUCTURE PROJECT FOR THE CONSTRUCTION OF WATER SUPPLY  
SYSTEM FOR LEMERY WATER DISTRICT, LEMERY ILOILO .**

- A. The following person/entities shall be allowed to participate in the bidding:
1. Duly licensed Filipino Citizen/Sole proprietorship;
  2. Partnership duly organized under the law of the Republic of the Philippines and of which at least Seventy Five Percent(75%) of the interest belongs to citizen of the Philippines;
  3. Corporation duly organized under the law of the Philippines and which at least Seventy Five Percent (75%) of the outstanding stock belong to citizen of the Philippines;
  4. With valid PCAB License ,minimum of **Size Range of Small B and License Category of C & D** with specialty in Water Supply
  5. Lists of contractor's personnel and lists of contractor's equipment units **shall be submitted under oath and notarized.**
  6. Each bidder shall submit **One(1) original and three (3) copies of the first and second components of its bid;**
  7. The infrastructure project is packaged in a single lot and the lot shall not be divided into sub-lots for the purpose of bidding, evaluation and contract award.
